3. Description of the Material Information or Fact :
 - I. PT CSM Corporatama (“PT CSM”), one of subsidiary which 89,61% of its shares indirectly owned by the Company through PT Indomobil Multi Jasa, Tbk and PT IMG Sejahtera Langgeng, has established a joint venture company with Seino Holdings Co., Ltd. (“SEINO”), namely PT Seino Indomobil Logistics Services (“PT SILS”), domiciled in East Jakarta.
 - II. PT SILS was established by virtue of the Deed No. 22 dated 18 January 2016, made before Wiwik Condro, SH, Notary in West Jakarta. PT SILS engages in the business of information technology activities and services.
 - III. The composition of share ownership in PT SILS is as follows:
